# QUALIFICATIONS FOR VOTING AND REGISTRATION

# You are qualified to VOTE in the Primary or General Election if:

- You are a citizen of the United States:
- You are at least 18 years of age or will be on the day of the general election;
- You are a resident of Ohio for at least 30 days immediately before the election:
- You are not in prison for a felony conviction;
- You have not been declared incompetent for voting purposes by a probate court.

# Registration deadline:

- You have been (at the time of the election) a resident of the state for thirty (30) days.
- You registered to vote 30 days prior to the election.
- You have a valid registration.

### You must RE-REGISTER if:

- You have moved since last election (a move within the county requires only a change of address form, if the registration is otherwise valid);
- You have changed your name.
