## REGISTRATION AND VOTING INFORMATION

### You are qualified to VOTE in the Primary or General Election if:

- You are a citizen of the United States;
- You are at least 18 years of age or will be on the day of the general election;
- You are a resident of Ohio for at least 30 days immediately before the election;
- You are not in prison for a felony conviction;
- You have not been declared incompetent for voting purposes by a probate court.

### Registration deadline:

- You have been (at the time of the election) a resident of the state for thirty (30) days.
- You registered to vote 30 days prior to the election.
- You have a valid registration.

### You must RE-REGISTER if:

- You have moved since last election (a move within the county requires only a change of address form, if the registration is otherwise valid);
- You have changed your name.

### Absentee ballots:

Applications for absentee ballots may be obtained by calling the Clermont Co. Board of Elections at **513-732-7275** or by visiting their website at [www.clermontelections.org](http://www.clermontelections.org).

### Who can register to vote?

- Those who are U.S. Citizens and 18 years old or older on or before the day of the general election

### Who must update their registration?

- Those who have moved within the county and not filed a change of address with the Board of Elections
- Persons having changed their name must file the name change information, including their former name, with the Board of Elections

### Who may vote by absentee ballot?

- Any registered voter

### JUSTICES SUPREME COURT OF OHIO

Justices are elected to six-year terms on a nonpartisan ballot. Two justices are chosen at the general election in even-numbered years. In the year when the chief justice runs, voters pick three members of the Court. A person must be an attorney with at least six years of experience in the practice of law to be elected or appointed to the Court. Appointments are made by the governor for vacancies that occur between elections.
